The following information has been provided by the property and outlines the Accessible facilities available. Bathrooms

- level entry or ramp access is provided through the entry door
- an entry door with a minimum width of 800mm or wider when open is provided
- a minimum clear circulation space of 2500 x 1900mm is provided
- grab rails installed within reach of the toilet, at the back and side at a height of 800 – 810mm are provided
- a minimum space of 950mm beside the toilet is provided
- a shower area is on a level floor surface free of any step, hob or sliding door track
- minimum 1100 x 1160 floor space inside the shower and a minimum 1400 x 1400 outside is provided
- shower fittings that can be accessed from a seated position are provided
- a shower chair or seat is provided
- lever or sensor operated taps are provided
- leg clearance underneath the hand basin is provided
- a mirror that can be used from a seated position is provided

Bedrooms

- level entry or ramp access is provided through the entry door



- an entry door with a minimum width of 800mm or wider when open is provided
- minimum space of 2070mm x 1540mm to manoeuvre a wheelchair easily around all areas of the room is provided
- choices of bed types e.g. single, double are provided
- movable furniture, including beds to provide space for a transfer hoist if required is provided
- adjustable height bed with clearance underneath for the legs of a hoist is provided
- tea and coffee making facilities that can be accessed from a seated position are provided
- remote controls for appliances e.g. TV, Video, DVD, air conditioner, lights etc are provided
- power points and switches that can be accessed from a seated position are provided
- light switches within reach of the bed are provided
- a storage area for mobility aids is provided
- large windows to maximise the view are provided
- a talking or large print alarm clock is provided
- a visual and/or vibrating alarm clock is provided

Booking and Communication Systems

- an accessible website is available for on line bookings
- Email is available for bookings
- Fax is available for bookings
- telephone bookings are available

Car Parking

- A designated accessible car parking bay is provided close to the entry with a minimum width of 3200mm and minimum overhead clearance of 2500mm.

Conference and Meeting areas

- accessible car parking is provided near the entry
- level entry or ramp access is provided through the entry door
- an entry door with a minimum opening width of 800mm or wider when open is provided
- movable furniture, including chairs and tables to for easy access are provided
- chairs with backs and armrests are provided
- tables that can accommodate a person sitting in a wheelchair are provided
- tea and coffee making facilities that can be accessed from a seated position are provided
- remote controls for appliances e.g. TV, Video, DVD, presentation screen, air conditioner, lights etc are provided



- power points and switches that can be accessed from a seated position are installed
- adjacent accessible 'break out' room for smaller groups are available
- wheelchair accessible presentation area or stage is provided
- direct access to an accessible toilet is provided

Guest Services

- meals can be delivered to guest rooms
- newspapers can be delivered to guests rooms

- clear manoeuvring space for a person using a mobility aid is provided

- visible and audible alarms are provided in each room
- emergency management procedures are developed that consider the needs of people with a range of disabilities.
